

● Fill out the JBF McKinney Valet Tagging Agreement

Our Valet Tagging Leader will match you with the nearest available Valet Tagger. Your Valet Tagger will try to reach out to you within 2-3 business days.

● Print your JBF McKinney Valet Tagging Agreement

Bring a copy with you to Drop-off with your Valet Tagger. They will need the information on there.

● Print any waivers

Print waivers, fill out waivers completely, and bring them with you to Drop-off with your Valet Tagger.



Safety Waivers Required for all Cribs & Car Seats

● Gather & Sort

Gather and Sort by size the items you'll be selling. Please read Steps 1 & 2 of our Seller Guide (that's pages 1-4). Failing to complete these steps may result in Fees.

● Communicate with your Tagger

You and your Tagger will arrange a time for you to drop your items at their chosen location. (Some taggers may choose to offer pickup service for an additional fee that they set themselves and is due to them in cash at the time of pickup.)

● After that, your experienced Valet Tagger will handle everything until they've drop your items off at the Sale.

● You'll receive a check for your sold items within two weeks of the end of the sale.

The Details...



- You will earn 45% of your sales. Your Valet Tagger will earn 20% of your sales - so they're motivated to price items correctly!
- A \$20 VT Supply Fee will be taken out of your Consignor Check after the sale. It will cover the cost of hangers, pins, paper, tape, etc.
- All items must be in excellent used condition (No stains, odors, pet hair, visible wear, missing pieces or defects). All items should be Clean, Current, Complete and Compliant.
- No recalls (you can check your items at www.cpsc.gov)
- You must have a minimum of 100 items and a maximum of 350 items, including clothing, shoes, toys, big items, baby gear to use this service. The more items you bring to your Valet Tagger, the more sales you'll have and the bigger your check will be!
- Valet Taggers are available on a first come, first served basis. They may fill up. JBF McKinney does not guarantee availability of Valet Taggers.
- All items **MUST** be delivered to the Tagger at least two full weeks before the sale.
- **All** Valet Tagged items will be marked to Half Price during our Half Price Sale.
- We recommend all Valet Tagged items be marked to Donate at the end of the Sale. However, if you choose to pick up your items that is your responsibility, not your Valet Tagger. This decision will need to be made before your Valet Tagger starts tagging for you.

Valet Tagging Fees



\$20

Everyone using our Valet Tagging Service will pay a VT **Supply Fee** which will be taken out of their Consignor Check after the sale. It will cover the cost of hangers, pins, paper, tape, etc.



\$0.25

Per “No Thank You” item. A “No Thank You” is anything that is deemed to not meet JBF McKinney standards for any reason. This includes, but is not limited to: stained, torn, visibly worn, broken, incomplete, no brand tag, no size tag, recalled, unsafe, dirty, unreadable foreign language tag, more than 5 years old. *This fee will be used at the Valet Taggers discretion.*

\$2

Per battery. It is your responsibility to replace all batteries so that all items are working/complete BEFORE you drop items with your Valet Tagger. *This fee will be used at the Valet Taggers discretion.*

\$10

For Not Sorting by size. Your Valet Tagger is trying to help as many people as possible so we ask that you respect their time by doing this step before you drop your items off. This fee will not be used if just a few items are mis-sorted. *This fee will be used at the Valet Taggers discretion.*

\$10

For less than 100 items. If you have less than 100 items that can be tagged by your Valet Tagger, she may charge this fee. This ensures that our Valet Taggers are adequately compensated for their time. *This fee will be used at the Valet Taggers discretion.*
